

**General Information and Requirements:** The Omni Redevelopment District Community Redevelopment Agency (OMNI CRA) is seeking proposals from qualified developers for a Design, Build, Operate and Manage Bid project to develop a Film/TV Studio at the OMNI CRA owned property located at 50 NW 14 Street. The selected firm will be required to provide the design, construction, financing, operations, management and maintenance of the facility. The OMNI CRA will own the land and the existing building as part of the development package. The proposal should be substantially consistent with the OMNI CRA Design Criteria Package for the facility and provide the studios and amenities outlined in the proposed MEC project. All proposals must include a detailed description of the project, site plan and renderings, management / operations/maintenance plan, background information on the developer's proposed development team and development expertise (specifically related to studios), a list of all persons with an interest in the developer, and recommendations from recent clients. Proposals must also demonstrate the financial and legal ability of the proposer(s) to carry out the project, including information on the financial status of the developer, a project budget consisting of a detailed pro forma demonstrating sources and uses of funds, including funding for management/operations and maintenance, details of the "teams" experience in the Film and Entertainment Industry and a detailed statement of all financial assistance needed from any/all source. Successful bid respondents will be expected to enter into a Professional Services agreement and the Operator is expected to enter into a Lease Agreement with the OMNI CRA.



**Background and Existing Conditions:** The proposed Miami Entertainment Complex (MEC) is a facility owned by the Omni Redevelopment District Community Redevelopment Agency (CRA) located at 50 NW 14 Street, Miami, Florida. This property is located less than 1500 feet west of the Performing Arts Center and is within the designated Media and Entertainment District of Downtown Miami. This 1947 built warehouse building once known as the Miami Skills Center Building and was previously owned by the Miami-Dade School Board. The Building was recently acquired by the OMNI CRA with the intent to transform it into a world class film studio complex. The property is located within the Miami 21 zoned D-1 district. The building has a footprint of approximately 78,560 SF. The building is currently a warehouse facility with average ceiling heights of approximately 18 feet. At the northeast corner of the building is a two story space that once held classrooms of approximately 5,890 SF. The building footprint covers the entire site with zero setbacks on any of its sides. The Florida Department of Transportation (FDOT) owns the vacant property adjacent to and on the south side of the facility. The O M N I CRA is leasing this parcel from FDOT to use as the parking/loading area. The building is bound on the north side by NW 14 Street which is currently undergoing a complete Streetscape reconstruction project funded by the OMNI CRA. In addition to the adjacent FDOT parcel, approximately 200 additional parking spaces are available to the south underneath 1-395 that can be leased from the Miami Parking Authority. The building is also adjacent to the FEC right-of-way on the west side. A survey of the property was performed when the OMNI CRA acquired the property and is available for review. No as-built plans of the building are available.

**Proposed Project:** The intent of the project is to develop a state of the art film studio complex that will provide the infrastructure necessary to attract TV series, Commercials and Big Screen film productions, as tenants for the use of the facilities year round.

The Respondents shall consider the following minimum characteristics:

- Raise the entire or portions of the buildings present roof.
- Provide for "FLEX" office space in the N. E. quadrant.
- Build at least two fully operational Film Sound Stages.
- Provide "Motion Capture Stage" Special Visual Effects Green Screen Stage.
- Provide new Electrical Grids, Plumbing, HYAC, Sound Proofing/Insulation, Vibration mitigation, Lighting and a Cat Walk Grid.
