



# Charles C. Bohl, Ph.D.

Charles C. Bohl is a research associate professor and director of the Knight Program in Community Building at the University of Miami's School of Architecture. The Knight

Program brings together outstanding scholars, architects, designers, community leaders, policymakers, theorists and practitioners with an active interest in the interdisciplinary process of community building and its relationship to the built environment of American villages, towns, cities and suburbs. In his role as director, Professor Bohl oversees all of the Knight Program's activities, including fellowship seminars and study tours held in cities throughout the United States, an annual symposium, an annual charrette, the work of graduate scholars in the Suburb and Town Design Program, and publications sponsored by the Knight Program. His book, Placemaking: Town Centers, Main Streets and Transit Villages, was published by the Urban Land Institute in 2002. Professor Bohl also consults in the fields of planning and urban design, and worked with Duany Plater-Zyberk on the Downtown Fort Myers Plan.

### Joseph P. Riley, Jr.

Mayor Joseph P. Riley, Jr. is widely considered one of the most visionary and highly effective governmental leaders in America. First elected Mayor in December 1975, Mayor Riley is serving an unprecedented ninth

term.
