1.1	Question: What is the contract term?
	Response: Page 6: "The CRA anticipates awarding a contract for one (1) year from the date of execution."
1.2	Question: Why is there no pre-proposal conference?
	Response: The CRA does not conduct pre-proposal conferences. As a procurement alternative, there is
	an allotted timeframe for a Question & Answer (Q&A) period to allow potential proposers to ask any
	questions they may have or receive additional information about the solicitation. After receipt of questions,
	our office forwards all questions and responses to all potential proposers and any other entities which have
	expressed an interest.
1.3	Question: Is the strategic plan available?
	<u>Response</u> : Pages 3 and 4 both indicate that supplementary information, i.e. the redevelopment Plan, an Economic Opportunity Assessment & Economic Development Action Plan can be found
	at: http://www.miamidade.gov/redevelopment/nw-7th-avenue-corridor.asp.
1.4	Question: Does the CRA have an office?
	Response: No, the CRA does not have an office location. However, the CRA's staff, who are employed by
	Miami-Dade County, are located at the Stephen P. Clarke Center ("Government Center"), 111 NW 1st Street,
	22 <sup>nd</sup> Floor, Miami, Florida 33128.
1.5	Question: How many staff are currently on site?
	Response: There is no staff on site, as the CRA does not have an office. However, Miami-Dade County
	provides staff support to this and the three other unincorporated CRA's located in Miami-Dade County.
1.6	Question: We do not understand the 10 FTE requirement, please explain.
	Response: Pursuant to Miami-Dade County Code 2-8.5, there are three criteria which establish a local
	preference, of which 10 full-time equivalent staff are one of the criteria.
1.7	Question: Does the budget include out-of-pocket expenses? It equates to an hourly rate of roughly \$64.00
	per hour.
	Response: As part of the negotiation with the successful bidder, out-of-pocket expenses will be negotiated.
