Dear Mr. Padgett:

Please find enclosed a copy of the CRA 2012 / 2013 Budget, minutes of December 12, 2013, Resolution 2013-08, and the financial report ending September 30, 2013. The Town's Phase II of its Streetscape Project was completed in the 2012 / 2013 fiscal year.

Below is a summary of the Town's Streetscape Project funded in part with TIF funds.

The Town of Cinco Bayou has completed Phase I of its Streetscape Project along the Eglin Parkway Corridor from Hughes Street north to Irwin Ave. as part of the CRA Plan. The completion date for Phase I was March 15, 2011. The Phase I Project was funded with CRA Tif funds received from Okaloosa County and the Town of Cinco Bayou along with a \$600,000 Community Development Block Grant (CDBG) and a \$147,000 from a \$237,500 Capital Improvement Loan. Phase I consisted of relocating utility lines from above ground to underground, replacing sidewalks with decorative pavers and adding decorative lighting.

The Town was awarded a second CDBG grant in the amount of \$600,000 in February 2012 and completed Phase II from Irwin Ave north to Yacht Club Dr. in May of 2013. Phase II of the Streetscape Project is was funded with the \$600,000 grant, CRA Tif funds received from Okaloosa County and the Town of Cinco Bayou, the remaining \$90,000 from the Capital Improvement Loan and \$125,000 from the Town's reserves. Phase II consist of relocating utility lines from above ground to underground, replacing sidewalks with decorative pavers and adding decorative lighting. All of our CRA funds are currently committed to this project.
