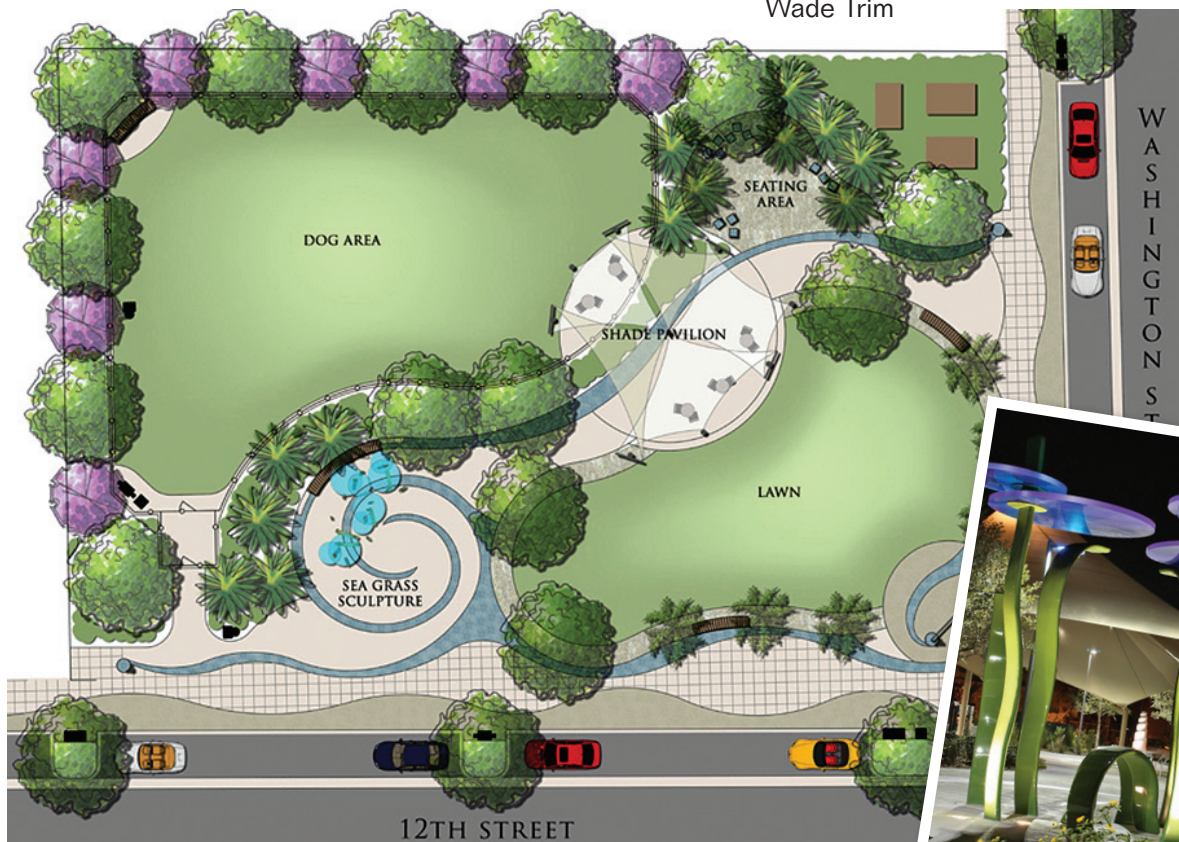

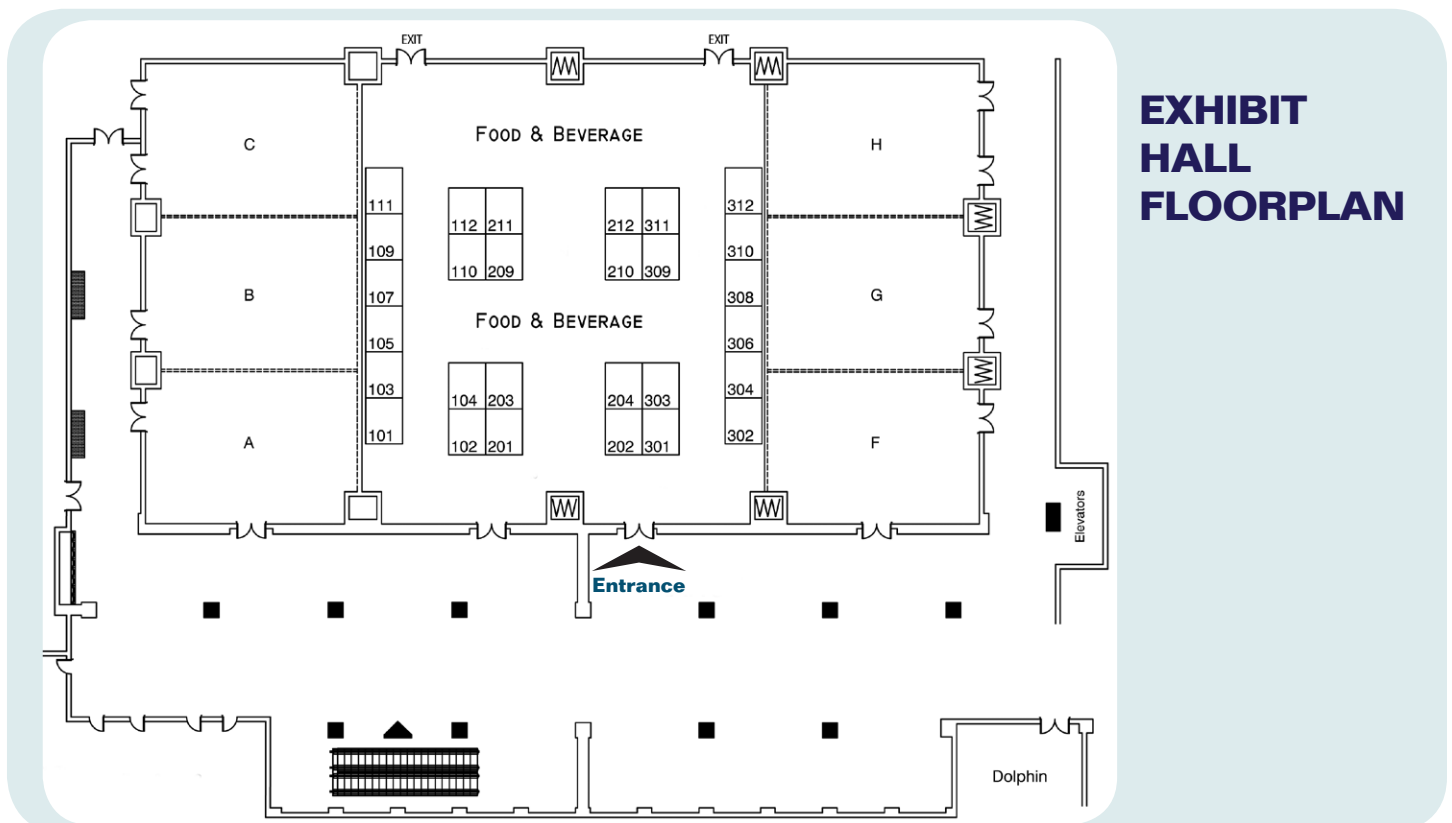

The most successful to date is the NCAA Division II strategy highlighted on the Web site [www.diicommunity.org](http://www.diicommunity.org). Luker is currently developing similar strategies for high schools through the National Federation of State High School Associations and through Minor League Baseball. In 2009, Luker published *Simple Community*, which documents the loss of the American community and provides a way for American companies to invest in restoring community.
