Bid packages will be received by the City of Live Oak - City Clerk for the Services, which shall be included under one contract.

- Provide: Two or Three options for Decorative Municipal Lighting, similar to the current decorative lighting along US 129 and US Hwy 90 in Downtown Live Oak and a lighting/photometric plan for each fixtures use as described in the RFP and or by the CRA Director. Proposals shall be addressed to the Live Oak City Clerk and delivered to the City Clerk's Office, located at 101 White Avenue SE, Live Oak, Florida, 32064 no later than **11:00 a.m. on Thursday, June 5, 2014.** Proposals shall be designated as "**Rail Trail Lighting Plan and Fixtures**".

**\*\*\*Contractor's required Demonstrable Experience & Qualifications:** Experience in providing Decorative Municipal Light Fixtures and Lighting Plans to support and enhance pedestrian corridors in multiple environments, and experience with sourcing the best fixtures by managing identified design and operational criteria against appropriate available products. Vendor should be able to demonstrate and provide cost projections for operational costs, maintenance, power and replacement/useful service life and have substantial past work experience in providing Efficient Municipal Lighting solutions and products.

All proposals must be submitted in **triplicate**. Any proposal received after the specified time and date will not be considered. The sealed proposals will be publicly opened at 11:15 am on Thursday, June 5, 2014 at City Hall, Council Chambers at the above address.
