The deadline for conference registration is October 9, 2017, and to receive a refund please tell us in writing by October 1, 2019 – it is subject to a \$50 per person processing fee.

NOTES

FRA dues must be paid prior to the conference to receive the member discount. Indicate member rate if you intend to pay the FRA dues for 2019-20. Online payments for dues will be available after September 1, and when we receive payments you will receive a receipt. (see notes on dues below)

All the mobile tours, and the CRA Boot Camp require a separate payment of \$50 on the form/online.

If you are registered for Friday, you do not need to register for the **Legal or Ethics sessions**. However, please register and pay for those sessions if you are just coming in for Legal or Ethics courses on Friday morning. There will be AICP, IEDC and FL Bar credits of 1.5 hours for those courses.

***HOW DO I TAKE CARE OF MEMBERSHIP FOR THE CONFERENCE REGISTRATIONS?**

In order to receive the member rate at FRA events, your membership must be “active”.

Since FRA membership is from October 1 – September 30, if you are members this year, fill out the registration for each person representing your company, government or organization who is a current active member, and check the boxes for “member” rate.

We send out dues notices around the first of September, to the person listed at the top of your contacts in the FRA membership directory.
