GNVCares

The City's Response to the Immediate Recovery of Gainesville

GNVCares is a plan to reprogram existing resources as well as allocate federal and state dollars that the City of Gainesville will receive under the CARES Act. Under GNVCares we will provide direct assistance (grants) to our businesses and neighbors.

This is the first phase of a plan which will be expanded upon the availability of additional resources. It is intended to be a starting point, not an end.

GNVCares About Neighbors

This program is designed to assist households (neighbors) who are in the extremely-low, very-low, low, and moderate income categories¹ that were financially impacted during the COVID-19 pandemic with temporary rent/mortgage and utility payments for up to 2 months, not to exceed \$1,250. The program would be funded with \$1,593,000 from SHIP, General Fund and CDBG sources.²

Minimum criteria:

- Income verification to demonstrate extremely-low, very-low, low, and moderate income levels, with priority given to extremely-low, very-low and low income neighbors.
- Proof that COVID-19 pandemic caused unemployment or reduction in work hours which resulted in a reduction of wages.

Demographic information of applicant head of households will be collected, but not used for evaluation, and shall include: (1) race/ethnicity; (2) gender; (3) primary and secondary language; (4) disability status; and, (5) veteran status.

GNVCares About Businesses

This program is designed to assist City of Gainesville small businesses⁶ that saw their operations curtailed as a result of the COVID-19 pandemic with a \$5,000 grant⁷ to offset costs such as rent and utilities. The program would be funded with \$1,593,000 from General Fund, CDBG and GCRA sources.

Minimum criteria⁸ would be:

- Business must be located in the City of Gainesville as of March 16, 2020.
- Loss in revenue due to public health restrictions (i.e., Emergency Orders).
- Maximum of 50 employees.
- Operations halted/curtailed by Emergency Orders
- Have current Business Tax Receipt from the City of Gainesville.
- Business has not received "Payroll Protection Program" funds and/or "SBA Disaster Assistance in Response to the Coronavirus" funds.
- Business has no pending petition for bankruptcy protection.
- Good faith efforts to provide pay/benefits to furloughed employees; retention of employees
- Local ownership (non-corporate store)

Applications will be furnished to EO, HCD and GCRA to determine compliance with their respective programs. Applications will be determined to be eligible by the City Manager. At the conclusion of the application period, eligible applications will be awarded in a randomized manner.

The City would contract with Capital Access¹¹ (City's HUD Consultant) to implement an on-line application program, administer funding (General Fund, CDBG and GCRA) criteria and reporting requirements and assist staff in the review of applications for sufficiency. The City would also have certain protections in place to guard against fraud resulting in claw back of grant funds.

Additional efforts to assist small businesses:

- Working Food \$15,000 grant administered through the Community Foundation to provide food to distressed families.
- Feed GNV supporting restaurants by buying food to augment feeding to vulnerable communities (homeless neighbors). *Launched*
- Assisting the local arts and performance community through scheduling virtual concerts and performances.
- Advanced buying from local suppliers.
- Rental forbearance for tenants where City is the landlord.

GNVCares is a work in progress and will be adapted as economic conditions warrant.
