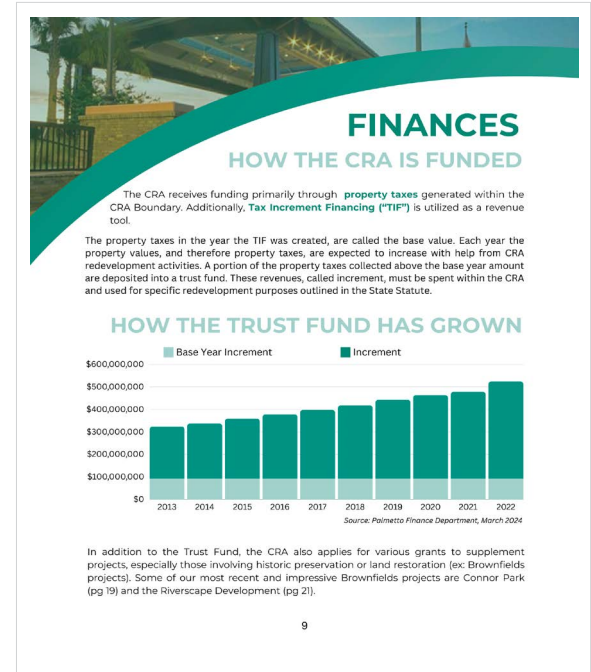

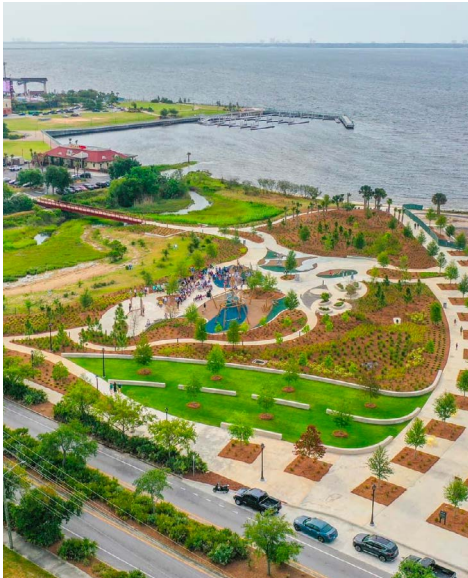

City of Pensacola Community Redevelopment Agency
Bruce Beach 107 Years of Transition

A 10-acre property along Pensacola’s waterfront was once a thriving industrial hub serving the early 20th-century maritime industry and later a neighborhood gathering place for Pensacola’s black community. The property, known as Bruce Beach, was a littered homeless camp by the mid-1970s. This all changed with the recent completion of phase one of a two-part reactivation plan by the Pensacola CRA to create a connected, accessible public realm along the water’s edge. Today, Bruce Beach is transformed into a waterfront park with a central plaza, native plants, cultural exhibits, wildlife-friendly lighting, shade structures, a learning garden and a pedestrian bridge that overlooks historic Washerwoman Creek.

City of Orlando DOB/CRA
An Ode to Third Places

In 2023, a new CRA open-space approach activated small, underutilized downtown properties by transforming two corner sites into art gallery plazas, part of the initiative "An Ode to Third Places." Supported by the Orlando Economic Partnership, Commissioners and Mayor, the first site at 30 S. Orange Ave. featured quick-build modifications and a Visit Orlando global mural campaign. The second site at 1 N. Rosalind Ave. involved a multiyear effort culminating in property acquisition with partners. This site, the gateway to Lake Eola Park, showcases Achromatic Aria Fresco, celebrating Orlando's diversity.

Legacy Credit: Innovation Lies at the Heart of
Community Redevelopment

The Legacy Credit Initiative, introduced by the City of Tampa Community Redevelopment Agency, innovatively tackles common barriers hindering property improvement grants. By reducing or eliminating owner-match requirements and facilitating direct contractor payments, the initiative encourages long-term property owners to enhance their properties without bearing substantial upfront costs. This not only fosters community stability but also incentivizes continued private investment, job creation and amenities for residents. The program ensures fairness by capping credits at past Trust Fund contributions and tailoring match requirements based on ownership tenure. Notably, its adaptability and focus on inclusivity make it a model for similar communities.

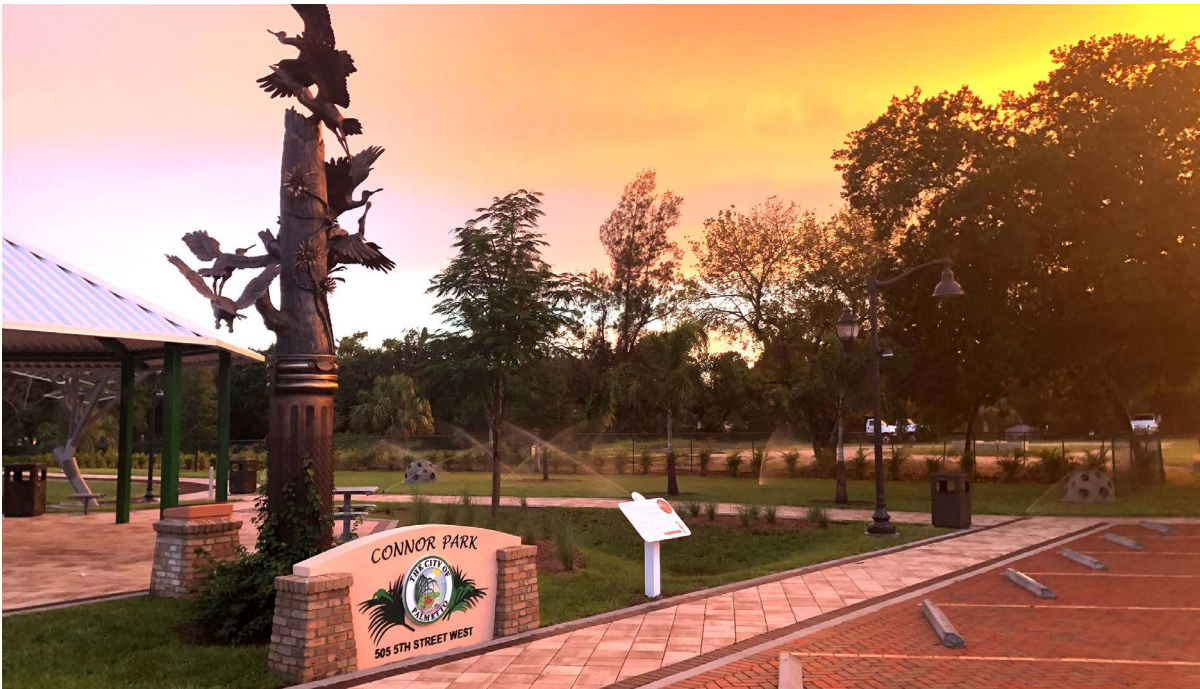

Flight of the Spoonbills

Palmetto has a long-standing commitment to the preservation of its wildlife and is, in fact, a bird sanctuary. With their striking pink feathers, roseate spoonbills were hunted to near extinction during the 1800s to decorate women’s hats and clothes. In celebration of Palmetto’s newest environmental park, the Community Redevelopment Agency’s CCNA design team was charged with creating a sculpture that captured the importance of Connor Park to Palmetto’s bird and wildlife population. From this request, “Flight of the Spoonbills,” a sculpture that celebrates the City of Palmetto’s devotion to enhancing the environment through projects like Connor Park, was created.

One hundred and ten families will call BL home along with two emerging entrepreneurs in the live-work lofts with storefront access to Broadway. Minutes from world-class beaches and a working waterfront, BL promises to upgrade lifestyles with its pool, dog park and pieces of modern art. 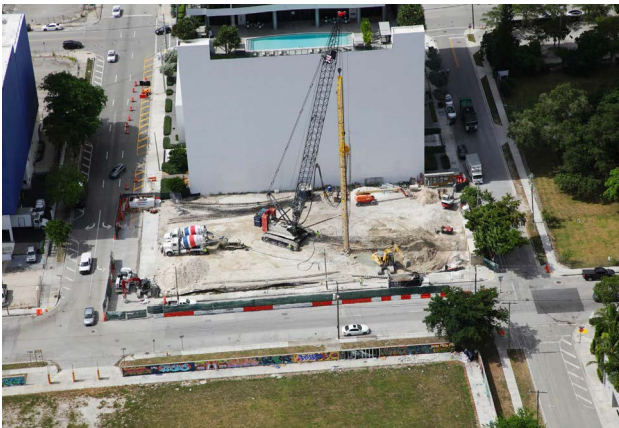


OUTSTANDING NEW BUILDING – LARGE CITY

Uni-Tower

Uni-Tower, a collaborative effort between the Omni Community Redevelopment Agency (CRA) and NR Investments, is a beacon of affordable housing in Miami's "Arts and Entertainment" neighborhood. This 29-story project features 252 rent-restricted residential units and 6,000 square feet of commercial space. It caters to diverse residents, including professionals and those transitioning from homelessness. With 95% completion, it exemplifies a holistic approach to urban development by incorporating public spaces and amenities to foster community engagement and sustainability. The Omni CRA's additional \$5 million grant highlights its dedication to delivering quality, affordable housing that enriches Miami's diverse communities.

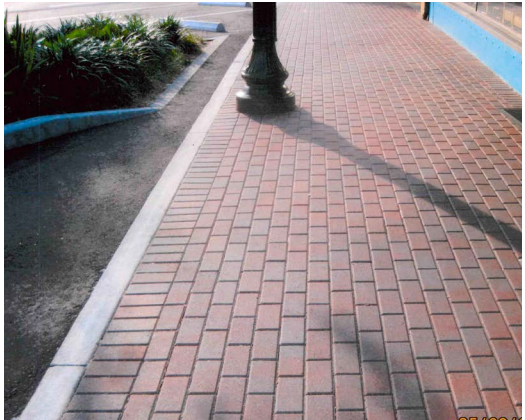
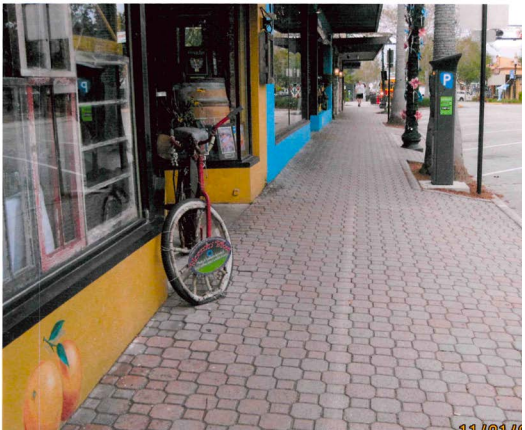

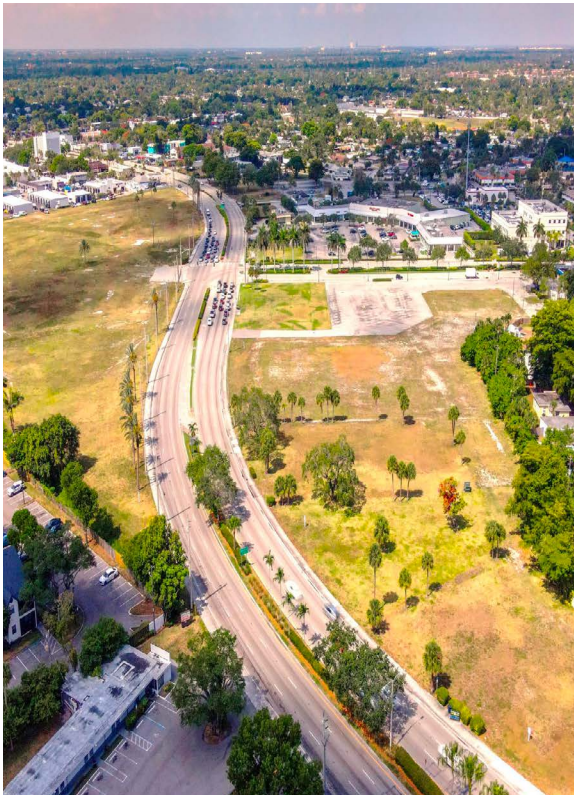

Placemaking Opportunity

Margate is On the Move and marching forward to achieve its longtime goal of redeveloping its downtown area into a robust mixed-use City Center development. The Margate Community Redevelopment Agency and the City of Margate partnered with Colliers International, a global commercial real estate company, to provide real estate brokerage, marketing strategy and advisory services. One component of the agreement was the preparation and solicitation of the Margate City Center Placemaking Opportunity Offering Memorandum. The purpose was for qualified real estate developers and investors to acquire a long-term ground lease for up to 50 acres of developable land for the construction of its future city center, which will be a vibrant place for residents to live, work, shop and play.

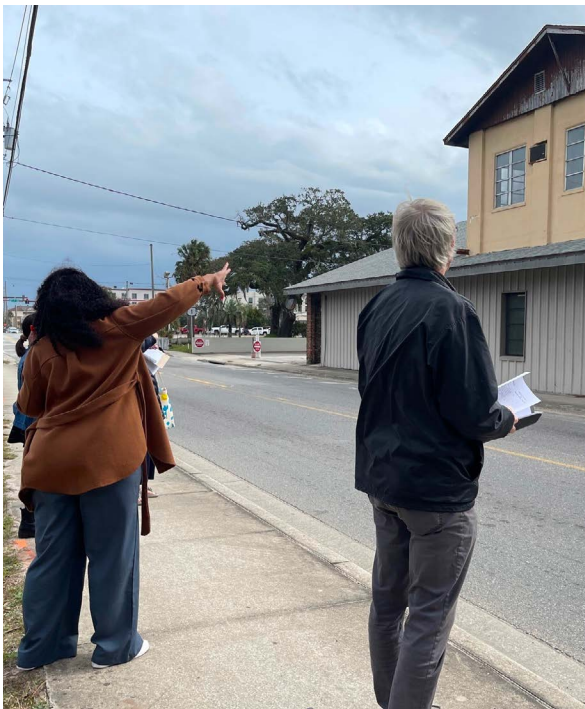

Establishing a CRA

The Finding of Necessity study serves as the initial step in creating a community redevelopment area. The establishment of a CRA is not an easy task. There is a massive amount of effort related to public engagement, data collection, field studies and meeting the State's compliance requirements. If the Finding of Necessity determines that required conditions exist, then the local government can establish a CRA. The study, completed with Inspire Placemaking LLC, is the first step in addressing challenges in West City. CRA staff members look forward to using the data collected to revitalize a once-thriving historic community.

Downtown Kissimmee Community Redevelopment Agency 308 Broadway Redevelopment

Since 1884, 308 Broadway was home to Makinson Hardware, the oldest hardware store in Florida, before it closed its doors in 2021 and was purchased by Z Family Assets LLC in 2022. The once-historic hardware store set an example of the power of redevelopment by transforming the 0.23-acre site into a thriving mixed-use center. Now home to 1881 Steakhouse, this project also included 10 market-rate apartment units and over 7,000 square feet of mixed office and retail space, all while preserving and honoring the rich history of the building.

2023 was the year of growth for the Lauderhill CRA. They continued to offer technical assistance programs at no cost to small-business owners and residents, along with the expansion of the CRA District, which included property acquisition where they can focus on investment, revitalization and beautification. Their 2023 Annual Report highlights these initiatives and also shares plans for the future.

**Town of Davie Community Redevelopment Agency
Fiscal Year 2023 Annual Report**

With a trailblazing, modern \$1 billion mixed-use building on the front cover, the first page says it all! As the words "dream, plan, accomplish" are prominently displayed across the front, it becomes apparent that this Annual Report doesn't just tell a story; it depicts a journey. It's a voyage birthed by a dream of revitalization, fulfilled by a plan of redevelopment and ultimately accomplished by public/private partnerships, community engagement, infrastructure improvements and creative planning. The Davie Community Redevelopment Agency (CRA) 2023 Annual Report shows impressive new projects, detailed financial data and heartwarming pictures of the people who matter the most to the CRA: the community.

**City of Pensacola Community
Redevelopment Agency
Bruce Beach 107 Years of Transition**

A 10-acre property along Pensacola's waterfront known as Bruce Beach was once a thriving industrial hub serving the early 20th-century maritime industry and later a neighborhood gathering place for Pensacola's Black community. The property, known as Bruce Beach, was a littered homeless camp by the mid-1970s. This all changed with the recent completion of phase one of a two-part reactivation plan by the Pensacola CRA to create a connected, accessible public realm along the water's edge. Today, Bruce Beach is transformed into a waterfront park with a central plaza, native plants, cultural exhibits, wildlife-friendly lighting, shade structures, a learning garden and a pedestrian bridge that overlooks historic Washerwoman Creek.

**Downtown Boca and City of Boca Raton
Downtown Boca Northwest First Avenue
Beautification and Northeast Second Street
Pedestrian Walkway Project**

As Downtown Boca continues to grow and mature, the focus on maintaining and sustaining existing infrastructure is critical. The addition of a premiere high-speed rail station in December 2022 meant considering the commuter experience once they left the train, in terms of aesthetics and functionality. Enhancements were needed to extend the charm and elegance of the district to and from the station; therefore, the N.W. First Avenue Beautification and N.E. Second Street Pedestrian Walkway project was created and implemented. This pedestrian-friendly path provided comfortable connectivity for Brightline passengers to Downtown Boca's shopping, dining and culture.

**Margate Community Redevelopment Agency
Serino Park Renovations Project**

A magnificent \$2 million renovation project was completed for this highly visible and extensively used park alongside State Road 7 in one of the oldest neighborhoods in the City. Improvements included a hard-covered fitness court, a new playground with safety surfacing, covered picnic tables and benches, water features, a restroom, hardscaping, upgraded landscaping, decorative uplighting, security elements and more. A park identity sign at the entrance further enhances the beauty of the park. This renovation has resurrected a source of pride in the community and has made first-class recreation accessible to countless children who live in the neighborhood.

**Tampa Community Redevelopment Agency
Water Street Public Realm Improvements**

Water Street Tampa is a new neighborhood in the heart of downtown Tampa across 56 acres of previously underutilized land. The public realm improvements for the neighborhood put an emphasis on creating large, legible sidewalks with space for large trees, lush landscaping, street furniture, public art, wayfinding, café seating and space for events. The project's signature feature is the 45' sidewalk on the east side of Water Street that is the heart of the district. The landscape features Florida-friendly plants, robust soil systems, rain gardens and zones with permeable pavers.

**Town of Davie Community
Redevelopment Agency
Davie Road Phase III Roadway
Improvement Project**

The transformation of the Davie Road corridor is nothing short of astounding! The Davie Road Phase III Roadway Improvement Project morphed an aged and busy thoroughfare into a multimodal Complete Street. Through partnership with Broward County's Mobility Advancement Program (Map Broward), this \$5 million infrastructure project refaced the entire corridor with pedestrian-friendly elements and aesthetic enhancements to improve the overall quality of the street. With western-themed street furniture, drainage improvements, flourishing landscaped medians, broadened sidewalks, new lit crosswalks, fresh paving and signage, Davie Road truly reflects a quaint and charming sentiment that is conducive to having a livable and walkable corridor.

Downtown Orlando, DDB/CRA
An Ode to Third Places: New Directions in Open Space Planning, Public Art and Community Partnerships

In 2023, a new CRA open-space approach activated small, underutilized downtown properties by transforming two corner sites into art gallery plazas, part of the initiative “An Ode to Third Places.” Supported by the Orlando Economic Partnership, Commissioners and Mayor, the first site at 30 S. Orange Ave. featured quick-build modifications and a Visit Orlando global mural campaign. The second site at 1 N. Rosalind Ave. involved a multiyear effort culminating in property acquisition with partners. This site, the gateway to Lake Eola Park, showcases Achromatic Aria Fresco, celebrating Orlando's diversity.

Downtown Orlando, DDB/CRA
Incentivizing Businesses, Establishing DTO as a Vibrant Destination

The 2023 updates to the Downtown Commercial and Residential Building Improvement Program aimed to address rising construction costs and enhance downtown Orlando's vibrancy. The creation of the DTO Façade, DTO Retail and DTO Restaurant Programs was central to this goal by supporting property owners in maintaining facade features and establishing downtown as a lively retail destination.

City of Sebastian Community Redevelopment Agency
Sebastian CRA Sustainable Economic Redevelopment Master Plan

The Sebastian CRA received a Community Planning Technical Assistance Grant of \$70,000 from the Florida Department of Economic Opportunity and retained GAI Community Solutions Group to update the Sebastian Riverfront CRA Redevelopment Plan. The Redevelopment Plan update incorporated economic development strategies that aid the Sebastian CRA in defining markets, designing infrastructure projects that address growth and capturing the essence of the City of Sebastian in a comprehensive, compatible design. Created and accepted to advance the City's vision, the Redevelopment Plan update aids in identifying sustainable strategies and opportunities for the future of Sebastian's core urban areas.

City of St. Cloud
Economic Gardening Program

The Downtown Economic Gardening Program was an innovative, multilayered suite of financial and technical assistance programs offered for businesses affected by the pandemic and prolonged construction of the CRA's streetscape and infrastructure project. Many businesses were facing closure. The program was launched to support the 97 small and midsize businesses in the downtown district by providing resources to assist in business continuity and sustainability while they were plagued with a lack of sales. The program offered \$190,000 in assistance including grants, technical support, fee waivers and marketplace information.

City of Tampa Community Redevelopment Agency
Historic Seventh Avenue Iconic Illuminated Archways and Streetscape

In 2023, 21 iconic lighted archways were installed along Ybor City's historic Seventh Avenue, which has been named one of the greatest streets in America. The original archways, installed more than 30 years ago for the National Historic Landmark District's centennial celebration, deteriorated over time. The new archways were improved with code-compliant structural and aesthetic enhancements in accordance with historic preservation standards. The success of this project hinged on strong partnerships forged between Ybor City CRA and several regional partners that worked to fabricate environmentally sustainable lighted structures that span Ybor's premier commercial corridor.

Delray Beach Community Redevelopment Agency
Commercial Activation – Hatcher Construction & Development Inc. Office Building

Hatcher Construction & Development Inc. is a family-owned business that provides construction and development services and has been in Delray Beach since 1999. By using the CRA's Incentive and Funding Assistance Programs, Hatcher constructed two two-story 3,556-square-foot commercial buildings totaling 7,112 square feet in the West Atlantic Corridor of The Set. This development is now the corporate office for Hatcher and allowed the company to grow from 13 to 24 employees. Units are also available for other small businesses to rent affordable space. The Hatcher family now has a permanent home for their business in the heart of Delray Beach.

Hallandale Beach Community Redevelopment Agency
The Cloud EV Bus Fleet

There's more to Hallandale Beach than sunny days and an ocean breeze. As a leader in sustainable, smart progress, bringing green solutions to the City is a priority. The Hallandale Beach Community Redevelopment Agency (HBCRA) joined forces with the City of Hallandale Beach and the Florida Department of Transportation to transition the community bus shuttle into the Cloud, a fleet of nine fully electric buses to tackle climate change and congestion while offering free rides to every rider, every time. The Cloud, featuring accessibility ramps, complimentary Wi-Fi and expanded routes, means riding on cloud nine has never been easier!

**City of Tampa Community Redevelopment Agency
Ybor City YES! Team**

In November 2022, the Ybor City CRA launched a refreshed Ybor City YES! Team in partnership with Block by Block, a Louisville, KY-based company. Originally established in 2000 as the Ybor Environmental Services! (YES!) Team, the new partnership provides Tampa's National Historic Landmark District with enhanced cleaning and safety services. The new YES! Team serves as ambassadors of the district to help welcome guests, provide information and deliver cleaning services to maintain the visual aesthetic of Ybor City. The YES! Team also serves as additional safety personnel, interacting directly with local law enforcement to ensure the safety of Ybor City patrons.

**Omni Community Redevelopment Agency
Purple Shirts Program**

The Omni Community Redevelopment Agency (CRA) spearheads a \$310,000 urban revitalization initiative in downtown Miami through the "Purple Shirts Program." This effort employs 20 workers and offers competitive pay and specialized training in partnership with Camillus House Inc. and Chapman Partnership. Their tasks encompass trash removal, graffiti cleanup and landscape improvements, which enhance Miami's visual allure. Beyond aesthetics, the program underscores the CRA's commitment to cultivating a vibrant, inclusive and economically thriving urban space. This milestone signifies a significant step in downtown's renewal and showcases the Agency's dedication to enhancing Miami's landscape and fostering a better community.

**Riviera Beach Community
Redevelopment Agency
Clean and Safe Initiative**

The Riviera Beach Police Department and the Riviera Beach Community Redevelopment Agency (CRA) agreed to collaborate to address crucial quality-of-life issues in the CRA District. This groundbreaking initiative is marked by the participation of dedicated "Clean and Safe Ambassadors" and law enforcement officers, all uniting to make a visible and lasting difference in the heart of the City. Working tirelessly seven days a week, this dynamic team has set its sights on enhancing the CRA District by ensuring the safety and security of its residents and visitors and beautifying the area. Beautification, litter abatement and connections are key to success.

**City of Palmetto Community
Redevelopment Agency
Flight of the Spoonbills**

Palmetto has a long-standing commitment to the preservation of its wildlife and is, in fact, a bird sanctuary. With their striking pink feathers, roseate spoonbills were hunted to near extinction during the 1800s to decorate women's hats and clothes. In celebration of Palmetto's newest environmental park, the Community Redevelopment Agency's CCNA design team was charged with creating a sculpture that captured the importance of Connor Park to Palmetto's bird and wildlife population. From this request, "Flight of the Spoonbills," a sculpture that celebrates the City of Palmetto's devotion to enhancing the environment through projects like Connor Park, was created.

**City of Tampa Community Redevelopment Agency
Legacy Credit: Innovation Lies at the Heart of
Community Redevelopment**

The Legacy Credit Initiative, introduced by the City of Tampa Community Redevelopment Agency, innovatively tackles common barriers hindering property improvement grants. By reducing or eliminating owner-match requirements and facilitating direct contractor payments, the initiative encourages long-term property owners to enhance their properties without bearing substantial upfront costs. This not only fosters community stability but also incentivizes continued private investment, job creation and amenities for residents. The program ensures fairness by capping credits at past Trust Fund contributions and tailoring match requirements based on ownership tenure. Notably, its adaptability and focus on inclusivity make it a model for similar communities.

**Fort Myers Community Redevelopment Agency
Buck's Backyard Murals Project at Historic
McCollum Hall**

The Buck's Backyard Mural project, a transformative collaboration between the City of Fort Myers CRA, Public Art Committee and Fort Myers Mural Society, vividly revitalizes McCollum Hall's historic canvas. This mural suite serves as a vibrant, unifying emblem of cultural enhancement via striking aesthetic enrichment. The mural's theme masterfully transforms barriers into bridges and celebrates the kaleidoscope of cultural influences. This landmark project has transformed a mundane back wall into a living testament of cultural heritage and shared community vision, which makes Fort Myers a compelling and inclusive tableau of historical and contemporary expression.

**Jacksonville Beach Community
Redevelopment Agency
Public Art Implementation**

The Public Art Committee, established to assist the CRA, is dedicated to enhancing the downtown district with public art. Focused on executing a master art plan, the committee aims to enrich the community through creative expression. Public art plays a crucial role in fostering community identity and engagement. To date, the committee has successfully commissioned two murals and two sculptures, contributing to the cultural and aesthetic vibrancy of the area. By integrating art into public spaces, the committee strives to create an inviting and inspiring environment for residents and visitors alike.

**Margate Community Redevelopment Agency
Property Improvement Program**

The Margate Community Redevelopment Agency (MCRA) implemented an award-winning, fully automated application process that expedited processing times and streamlined customer support for a \$2 million Property Improvement Program (PIP) grant for commercial and residential property owners in the MCRA district. The grant is designed to encourage residential and business owners to restore, renovate and improve their property, thereby improving the area's visual quality and attractiveness and increasing property values. Residential properties can qualify for up to \$10,000 with a matching grant, while commercial properties could receive a 50% reimbursement grant of up to \$750,000. The application process facilitated this undertaking seamlessly.

**Martin County Community Redevelopment Agency
Ripple Stormwater EcoArt Project**

Ripple ... as a drop of water becomes a river, The Ripple Stormwater EcoArt Project is a unique combination of stormwater treatment, water quality, EcoArt, creative placemaking, education and community engagement. Ripple provides the opportunity to reconnect the Old Palm City neighborhood with the St. Lucie Estuary, which is the most biodiverse in North America, at four interconnected stormwater treatment areas by integrating artist-designed/ community-inspired elements. This one-of-a-kind, artist-led endeavor brought together the Old Palm City neighborhood residents, businesses, county staff, professional engineers and architects to create an unrivaled environmental amenity that enhances stormwater retention, improves drainage, increases water quality, educates the public and beautifies the community.

**Omni Community Redevelopment Agency
Citizens Bank**

The Omni CRA's ambitious project to rehabilitate the historic Citizens Bank Building is a testament to their commitment to preserving heritage while embracing modernity. Acquired in June 2017, the project, now 95% complete, focuses on restoring the building's integrity and aesthetic appeal while reversing years of natural deterioration. With a total investment of over \$7 million, this initiative underscores Omni CRA's dedication to revitalizing the Overtown area. By merging historical preservation with contemporary functionality, the project ensures that the landmark not only honors the past but also meets the evolving needs of the present and future community.

**Town of Davie Community Redevelopment Agency
“Let’s Talk Business”**

Every business has a story to tell, and we want to know that story! The “Let’s Talk Business” Small Business Recognition Program connects business owners with the community they serve through a customized and compelling, professional-grade promotional video. Implemented in 2023, this original program spotlights one business within the CRA every quarter at the CRA Board meeting. Each recipient receives an award, a photo opportunity with the CRA Board/Town Council and an inspiring promotional video created by Town staff. Business owners are also given the opportunity to share their storefronts, services, products and staff with the community.

OUTSTANDING HOUSING PROJECT

**City of Cocoa
Affordable Housing Public-Private Partnership**

The City of Cocoa, with Diamond Square CRA, Community Housing Initiative Inc. and Smith Development and Construction, is spearheading the construction of five affordable single-family homes through a pioneering public-private partnership. This innovative endeavor combines governmental resources, community involvement and private expertise to address the pressing need for affordable housing. Leveraging funding from multiple sources, including grants and local investments, the project aims to revitalize the community while providing quality, sustainable homes for low-to-moderate-income families. With careful planning, inclusive design and transparent communication, this partnership embodies a proactive approach toward tackling housing challenges and fostering neighborhood growth and stability.

**Hallandale Beach Community
Redevelopment Agency
Solaris Affordable Housing Project**

The Solaris project exemplifies the Hallandale Beach Community Redevelopment Agency's (HBCRA's) commitment to enhancing affordable housing options. Initiated during the coronavirus pandemic, this nearly \$30 million mixed-income residential building, constructed in partnership with The Cornerstone Group, faced significant challenges. Despite these hurdles, the HBCRA successfully helped create development that provides affordable housing and revitalizes one of the City's underserved communities. By integrating affordable and market-rate units, Solaris promotes economic diversity, fosters community resilience and aligns with HBCRA's mission to improve living conditions and stimulate local development. This project is a beacon of innovation and dedication to community improvement.

**Lake Wales Community Redevelopment Agency
Legacy Housing Rehabilitation Program**

The Legacy Housing Rehabilitation Program was created to honor seniors in the Northwest neighborhood of Lake Wales by providing free repairs to their homes. This program aims to offer support to ease some of the financial burdens that older adults may experience and enhance their living conditions. Since its launch in June 2021, this initiative has completed repairs on over 30 homes. Some of the improvements covered by the program include roof repairs, replacement of fascia/soffit, exterior painting and light construction work. Furthermore, the work done for the senior residents not only enhances their property value but also contributes to creating generational wealth.

**Omni Community Redevelopment Agency
Project Peach**

The Omni CRA's \$1.3 million grant for the mixed-use development at 123 N.W. 14th St. epitomizes its dedication to combating urban blight, fostering economic growth and creating affordable housing opportunities. The project was done in partnership with Caprock 123 LLC, a developer whose values seamlessly align with the CRA's vision. Project Peach's offerings range from serving as headquarters for local nonprofit Catalyst Miami to providing additional affordable housing units and offering space for entrepreneurs to develop their business ideas. Project Peach, in line with the 2019 Amendment to the Redevelopment Plan, symbolizes the Omni CRA's ongoing efforts to create a vibrant and inclusive urban landscape.

**Riviera Beach Community Redevelopment Agency
Berkeley Landing**

Berkeley Landing (BL) is a premier community of 112 rental homes consisting of one, two and three bedrooms for Riviera Beach’s working families. It is catalytic to the revitalization of the Broadway corridor and brings the first major redevelopment to this area in 40 years. One hundred and ten families will call BL home along with two emerging entrepreneurs for the live-work lofts with storefront access to Broadway. Minutes from world-class beaches and a working waterfront, BL promises to upgrade lifestyles with its pool, dog park and pieces of modern art. The striking design draws the eyes of the thousands of travelers and passersby.

OUTSTANDING NEW BUILDING PROJECT

**City of Oakland Park
Fire Station No. 9**

Fire Station 9 is a state-of-the-art facility in Oakland Park that replaces a 56-year-old station. This new 19,800-square-foot, two-story, three-bay fire station serves as a centralized hub for Fire Rescue operations and administration. Located in a Qualified Census Tract in the Community Redevelopment Area, it exemplifies the City's commitment to sustainability, public safety and community service. The station features innovative designs, including a metal facade made from recycled materials and renewable energy use. Additionally, it incorporates the Hot Zone concept, which enhances firefighter safety by minimizing exposure to contaminants through designated decontamination and clean zones. This project is a key component of Oakland Park's vision for its second century and reflects its dedication to strategic growth and community well-being.

**City of Ocala
District Bar and Kitchen Redevelopment Project**

The District Bar and Kitchen (DBK) redevelopment project is in the historic downtown of the City of Ocala. The 0.07-acre property was developed into a 6,700-square-foot high-energy restaurant and bar. The building embodies the Form Based Code planning district of Ocala's downtown, with its placement in relation to the street, floor plan and facade treatments. Construction of the building was completed in June 2023, and the grand opening followed shortly after. DBK provides a full dining experience with an elevated sports bar/food concept, live music and entertainment. The project was supported by incentives from the Ocala CRA and the City's Economic Investment Program.

**Omni Community Redevelopment Agency
Uni-Tower**

Uni-Tower, a collaborative effort between the Omni CRA and NR Investments, is a beacon of affordable housing in Miami's "Arts and Entertainment" neighborhood. This 29-story project features 252 rent-restricted residential units and 6,000 square feet of commercial space. It caters to diverse residents, including professionals and those transitioning from homelessness. With 95% completion, it exemplifies a holistic approach to urban development by incorporating public spaces and amenities to foster community engagement and sustainability. The Omni CRA's additional \$5 million grant highlights its dedication to delivering quality, affordable housing that enriches Miami's diverse communities.

**Omni Community Redevelopment Agency
Wynwood Haus**

Wynwood Haus is a landmark of community renewal in the Omni CRA District. It features 224 rental units and 5,200 square feet of retail space that redefines urban living with a vibrant community feel. This mixed-use project includes 100 affordable housing units that highlight the impact of urban renewal. Supported by the Omni CRA with a 95% Tax Increment Financing rebate and a \$1.1 million construction grant, Wynwood Haus exemplifies commitment to economic growth and sustainability. As a cornerstone of the area, it promises a future driven by collaboration and innovation.

**Pompano Beach Community
Redevelopment Agency
Old Town Square**

Old Town Square is the first market-rate, mixed-use development in the historic Old Town Arts and Entertainment District in Pompano Beach. Located in a blighted and transitional area, the developer faced a substantial financial gap and used the CRA's tax-increment financing incentive to bring the project to fruition, which established a real estate market that didn't exist previously. This \$62 million high-end development includes 281 apartments, ground-floor commercial spaces, a structured parking garage and luxury amenities targeting a younger demographic. Old Town Square officially opened in May 2024 and is estimated to generate \$9 million annually for the local economy.

**Tallahassee Community Redevelopment Agency
SoMo Walls**

SoMo Walls is a vibrant, new construction redevelopment project that fosters a catalytic addition to the public art scene in Tallahassee. Located near Cascades Park, this arts and entertainment hub blends artistic expression with modern retail spaces, which makes it accessible to residents and visitors. It features 14 rotating wall canvases amid 27,000 square feet of commercial activity, including food and beverage, fitness and event spaces. SoMo Walls aims to revitalize the south side and downtown Tallahassee by bringing revitalization to a previously underused and blighted area, which offers Florida's capital a platform to showcase its story through art. This destination is set to become a focal point for daily activities, community engagement and cultural exploration.

**Tallahassee Community Redevelopment Agency
Magnolia Oaks**

Located in the heart of Tallahassee and the greater Frenchtown/southside district, Magnolia Oaks is an affordable housing development consisting of 110 units. The community serves a mixed demographic of seniors and family households at varying income levels between 33% Area Median Income (AMI) to 60% AMI. Magnolia Oaks provides residents with services such as an employment assistance program, a family support coordinator and a financial management program to continue to educate and better the community. Residents also have access to amenities such as a large heated pool, a fitness center, a multipurpose community room/clubhouse and a playground.

OUTSTANDING REHABILITATION, RENOVATION OR REUSE PROJECT

**City of Dunedin
Downtown Pavers, Walkability and Enhancements**

The City of Dunedin was pleased to have replaced 25-year-old concrete sidewalks that were somewhat narrow and not ADA-compliant. The new sidewalks involved a 9-foot usable width vs. 6 feet.

**City of North Miami
Copperbridge**

This project transformed a dilapidated plantation house into a vibrant historical and cultural hub. It created a temple-like aesthetic by preserving original features such as Floridian pine floors and millwork and exposing structural beams with innovative lighting design. The space now serves as a venue for high-caliber exhibits, lectures and community events. An art garden featuring Latin American and Caribbean sculptures, lush tropical landscaping and ample seating enhances its cultural significance. This restoration, funded by private donations and a CRA matching grant, fosters community cohesion, offers educational opportunities and supports the arts and marks the start of a multiphase art hub in North Miami.

**City of Tampa Community Redevelopment Agency
The Well – “Live Well, Be Well, Feel Well”**

"The Well" represents a paradigm shift in community wellness! By transforming a former nightclub into a vibrant health hub, it offers a comprehensive range of services, from pharmacy and telehealth to counseling and transportation, which addresses East Tampa's healthcare gaps. Beyond healthcare, its impact resonates in community revitalization by reducing barriers to access and fostering partnerships for sustainability. Funding from various sources, including the East Tampa CRA, underpins its success. With plans for expansion and replication, The Well sets a precedent for community-driven healthcare innovation.

Its holistic approach, including mentorships and future service expansions, merits recognition and duplication.

**Delray Beach Community Redevelopment Agency
Focus on Fifth Initiative – Affordable Commercial
Activation**

This Affordable Commercial Activation Project was designed to revitalize and encourage economic activity in the CRA District. The property is on the historic Northwest/Southwest Fifth Avenue commercial corridor, which was once a bustling business area, dominated by black-owned enterprises. Rehabilitation and activation of this building was an opportunity for the CRA to provide affordable commercial retail/office space and funding assistance to small businesses in an important area of the District. The new building provides space for five retail bays on the first floor and flex/co-working space on the second floor.

**Downtown Kissimmee Community
Redevelopment Agency
308 Broadway Redevelopment**

Since 1884, 308 Broadway was home to Makinson Hardware, the oldest hardware store in Florida, before it closed its doors in 2021 and was purchased by Z Family Assets LLC in 2022. The once-historic hardware store set an example of the power of redevelopment by transforming the 0.23-acre site into a thriving mixed-use center. Now home to 1881 Steakhouse, this project also included 10 market-rate apartment units and over 7,000 square feet of mixed office and retail space, all while preserving and honoring the rich history of the building.

**Lake Worth Beach Community
Redevelopment Agency
Catapult Youth Mentoring Center
at Madlyn’s PLACE**

In 2019, the Lake Worth Beach CRA purchased a dilapidated property in the historic downtown. The commercial building, which at one time suffered major fire damage, had been vacant for over 20 years. After many setbacks, primarily due to construction delays during the COVID-19 pandemic, the CRA's hard work and determination were realized. The newly renovated building was dedicated in April 2024 as “Madlyn's Place,” named after the CRA's former Chairperson. The building will be leased to a local nonprofit organization to provide educational services, mentoring and college preparation to local high school and college students.

**Lauderdale Lakes Community
Redevelopment Agency
Lauderdale Lakes CRA Trailhead Park**

The Lauderdale Lakes Community Redevelopment Agency acquired a .22-acre site with a dilapidated building that was eventually demolished to construct a pocket park. The community identified the opportunity to design this park, known as the Trailhead Park, in a way that provides recreational activities and complements the greenway trails network. Youth from the local schools and programs inspired the creation of a wall mural that represents the elements of nature along the greenway trail and the metamorphosis of Lauderdale Lakes. Ultimately, a blighted area was transformed into a vibrant gathering space that connects people and places.

**Omni Community Redevelopment Agency
Bowles Apartment – Transformation Through
Community Collaboration**

The Bowles Apartments renovation that commenced in 2022 exemplifies the Omni CRA's dedication to affordable housing and sustainable communities. With Rebuilding Together, the CRA embarked on a transformative project to revitalize the historic six-unit residential building, steeped in a rich three-decade history under the Bullard family's ownership. Completed at a cost of just over \$600,000, this comprehensive renovation underscores the CRA's unwavering commitment to preserving affordable housing and fostering sustainable communities. Enhancing structural integrity and uplifting the neighborhood, the project serves as a beacon of hope and progress.

**City of St. Augustine Community
Redevelopment Agency
West City CRA Finding of Necessity Study:
Establishing a CRA**

The Finding of Necessity study serves as the initial step in creating a community redevelopment area. The establishment of a CRA is not an easy task. There is a massive amount of effort related to public engagement, data collection, field studies and meeting the State's compliance requirements. If the Finding of Necessity determines that required conditions exist, then the local government can establish a CRA. The study, completed with Inspire Placemaking LLC, is the first step in addressing challenges in West City. CRA staff members look forward to using the data collected to revitalize a once-thriving historic community.

**Community Redevelopment Agency of Bradenton
Bradenton CRA Sustainable Redevelopment
Policy Suite**

In October 2023, the Bradenton Community Redevelopment Agency staff began building a new foundation for its redevelopment mission. This foundation would be framed on sustainable economic development, synergizing economic, environmental and social benefits. Redevelopment plan rewrites for the downtown, central and Tamiami Trail redevelopment areas came first, followed by aligned grant, incentive, Community Advisory Committee and intergovernmental financing policies. The plans were written counter to the typical industry standard “drill down” analysis, which provided the agency with the maximum intent of the state redevelopment law and maximized the redevelopment board's opportunities with 16 grant and 18 incentive types.

**Margate Community Redevelopment Agency
50+/- Acre Margate City Center Placemaking
Opportunity**

Margate is On the Move and marching forward to achieve its longtime goal of redeveloping its downtown area into a robust mixed-use City Center development. The Margate Community Redevelopment Agency (MCRA) and the City of Margate partnered with Colliers International, a global commercial real estate company, to provide real estate brokerage, marketing strategy and advisory services. One component of the agreement was the preparation and solicitation of the Margate City Center Placemaking Opportunity Offering Memorandum. The purpose was for qualified real estate developers and investors to acquire a long-term ground lease for up to 50 acres of developable land for the construction of its future city center, which will be a vibrant place for residents to live, work, shop and play.

**Tampa Community Redevelopment Agency
West Tampa Community Redevelopment
Area Parking Study**

The West Tampa CRA Parking Study evaluates the existing parking conditions and identifies recommendations regarding parking management options for the West Tampa Community Redevelopment Area (CRA) in the City of Tampa. The study was conducted to address parking issues and parking-related problems that have been noted by businesses, residents and visitors. The study is designed to support the adoption of the Parking Master Plan for the West Tampa CRA. Overall, the study evaluated current parking inventory and its utilization, assessed the effectiveness of current parking management strategies and developed strategies to address existing and future parking needs for the community.

**Vine Street Community Redevelopment Agency –
City of Kissimmee
Vine Street Landscape Master Plan**

The Vine Street corridor is the primary spine through the City of Kissimmee and contributes to the overall image of Kissimmee. The Vine Street CRA developed the Vine Street Landscape Master Plan to further its goal of creating vibrant, attractive and inviting public spaces. Landscaping provides an immediate visual improvement to the aesthetic of the corridor. This collaborative effort spanned nearly one year and engaged residents, businesses and stakeholder organizations to address existing context and conditions, opportunities and constraints throughout the corridor. The result is an innovative plan that includes community-driven design principles and guidance for landscape beautification along the corridor.
